### FEBRUARY 21, 2023 COMMISSION MEETING MINUTES

Meeting Location: NH Fish & Game Department, 11 Hazen Drive, Concord, NH 03301.

Chairman Green called the meeting to order at 1:00p.m., and asked the audience to join in the pledge of allegiance. He informed the audience that the public is entitled to attend all Commission meetings and when recognized by the Chairman, the public may speak on any item on the agenda. The Chairman reserves the right to limit comment to the extent necessary for the orderly conduct of the meeting.

### **ACTION ITEMS:**

1. Commissioner S. Price moved to approve the January 17, 2023 Commission Minutes and Commissioner A.J. DeRosa seconded. Commissioner M. Lachance abstained from voting, as he was absent at the January 17, 2023 Commission Meeting. The motion carried.

1a.) On behalf of the Commission, Chairman R. Green presented the 2021 Youth Conservationist Award of Excellence to Jack Dalton, of Manchester, NH.



Chairman Green reported that Jack's mission is to protect animals and the environment though the power of education and inspiration. Jack Dalton, who goes by the name "Kid Conservationist", may be a child, but he is already an animal activist, public speaker, educational YouTuber, and author. Even though he is only 11 years old, he has already been recognized for his work both locally and globally, including the 2021 Presidential Environmental Youth Award, a 2021 International Eco-Hero by Action for Nature Notable Mention, and a Top 20 Finalist for the first-ever TIME Kid of the Year in 2020.

He further reported that Jack provides presentations at dozens of schools and libraries in New Hampshire about the ways kids can be involved in helping to protect wildlife for years to come.

In addition, Jack showcases his work on his YouTube channel "Kid Conservationist", which includes kayak river clean ups in Nashua, an interview with Nashua Mayor, Jim Donchess, about ways cities can go green to protect the environment. Jack's biggest project here in New Hampshire this year his "Save the Forest Lake" campaign, to help protect Forest Lake

State Park and voice his concerns about what would happen if a landfill were located close to the park. Some of the other topics he presents on are plastic use, palm oil, trash clean up, how to reduce paper usage, the importance of getting out in nature, and many other tips to help wildlife and the environment. NHPR, NH Chronicle, The Union Leader, and the New Hampshire Journal have all interviewed Jack Dalton.

Chairman Green thanked Jack & his parents for coming to the meeting and congratulated Jack on his achievements and receiving The Youth Conservationist Award.

The audience applauded.

Commissioner S. Price moved to support SB-256-FN, relative to establishing a safety program for off-highway recreational vehicles, and Commissioner P. DeBow seconded. The motion carried with 7 in favor, 2 opposed (R. Green & E. Stohl).

Chairman R. Green reminded the Commission to be cautious when discussing gun legislation.

He reported that he distributed a copy of the Draft Outreach Plan for Stakeholders Survey & the Stakeholder engagement questions to the full Commission.

### **NEW BUSINESS:** N/A

<u>COMMISSIONERS REPORTS</u>: Commissioners will report on their recent activities as it relates to Fish & Game Commission duties and responsibilities. This is an informational item only.

Commissioner A.J. DeRosa thanked Karen Bordeau, Small Game Project Leader, for allowing him to join her during the Wing & Tail Survey and for answering all his questions.

Commissioner S. Price reported that there were two reports of bobcats infected with rabies in 2022.

### **DIRECTOR'S REPORT:**

Director Mason reported that he recently attended the Bear Hunter's Meeting and the NH Trappers Association Banquet.

He reported that the Governor has presented his budget proposal to the Legislature.

He reported that the Governor has agreed to return a portion of the department's general fund monies, which were lost during the COVID period.

In addition, the Governor has also agreed to fund the four (4) unfunded Conservation Officer positions, two (2) of which will be funded out of the OHRV Fund and two (2) out of the general fund.

Governor Sununu also increased the department's GOFERR (Governor's Office for Emergency Relief & Recovery) grant for the Hatchery Rebuild Project by \$3.55 million dollars, in addition to proposing a capital budget item to replace the roof at Fish & Game HQ, recommending it be paid for with general fund monies.

Director Mason further reported that the Business Division did not get the new position funded, as requested, however, reported that it would be requested again before to the legislature.

He further reported that the request to move the part-time BOW (Becoming an Outdoor Woman) Coordinator position to a full-time position was also denied.

In closing, Director Mason reported that there is a proposed 10% staff salary increase for FY'2024 and a 2% raise for FY'2025. He reported that the Governor has proposed to pay for the first two years with general fund monies; however, the question arising now is how self-funded agencies will pay for the raise in future budgets, and what that may look like, which could involve radical changes.

### **CALL TO THE PUBLIC:**

Becky Philbrick, Hillsborough, NH – reported and described her attack by a rabid bobcat on her property. She reported that the both the States of Maine & Vermont have a bobcat season and asked the Commission to consider having a season for bobcat in New Hampshire as well, to manage the animals. Kristina Snyder, Chester, NH – inquired as to whether Conservation Commissions were included as stakeholders, and whether they would be able to participate in the Stakeholders Survey of the Draft Outreach Plan, as they work closely with the Fish & Game Department. She recommended obtaining Conservation Commission's feedback.

At this time, 4:17 p.m., Commissioner J. Caveney moved to adjourn and Commissioner E. Stohl seconded. The vote was unanimous in the affirmative.
