The State of New Hampshire, Fish & Game has a full time vacancy for a Fish Culturist II.

Summary: Assists in the cultivation and distribution of fish for use in New Hampshire ponds, streams and lakes and performs maintenance work at a regional fish production/wastewater treatment facility.

Responsibilities:

Oversees care and upkeep of production fish from eggs to adults (stocking size), and broodstock.

Calculates feeding rate for various lots of fish. Observes fish for signs of disease. Dispenses medications as necessary.

Takes samples for testing water quality parameters to ensure and maintain water quality.

Maintains bio-security measures to prevent introduction of pathogens.

Collects biological, physical, and chemical information in the preparation and submission of department and monthly hatchery/treatment plant records and reports.

Measures and records water flow, temperature, pH, dissolved oxygen, carbon dioxide, alkalinity, total gas pressure and nitrogen gas pressure. Records and documents the following: feed, cleaning, treatments for disease, mortality, and sample counts.

Prepares fish for transportation, loads fish into stocking trucks, and applies the skills necessary to transport and distribute fish into designated water bodies to meet the need for regional fisheries management. Assists in helicopter stocking of remote ponds ensuring water is suitable to receive fish.

Performs routine maintenance and repair of regional fish hatchery/ treatment plant equipment facilities and grounds. Maintains and repairs buildings, power equipment and specialty equipment used at hatchery facilities.

MINIMUM QUALIFICATIONS:

Education: High school diploma or high school equivalency credential. Each additional year of approved formal education may be substituted for one year of required work experience. Transcripts required

Experience: One year's experience as a Fish Culturist I or equivalent.

License/Certification:Must possess a valid Commercial Driver's License (CDL) with tank and air brake endorsements or obtain prior to completion of the probationary period. Motor Vehicle Record (MVR) must meet the minimum standards as established by the agency.

PREFERRED QUALIFICATIONS: Preference will be given to applicants that have knowledge of fish culture principles, understanding of environmental effects of wastewater pollutants, knowledge of best management practices and knowledge of wastewater treatment facility operation.

SPECIAL REQUIREMENTS:

- 1. Requires medium to heavy physical work with exposure to the elements, as well as being physically able to perform duties which include continuous strenuous activities such as frequent reaching, bending, lifting, walking, and operating machines or equipment.
- 2. Applicant must agree to controlled substance testing as required by the US Department of Transportation, prior to being offered a position. In addition, position requires controlled substance testing and alcohol testing of the following: random, post-accident, reasonable cause and follow-up. Applicant must agree to sign a previous pre-employment alcohol and drug test statement and sign authorization for the New Hampshire Fish and Game Department to obtain information from previous employer
- 3. On a case-by-case basis, depending on the facility, may be required to live in Fish and Game Department housing, as a condition of employment, to ensure surveillance to prevent theft and/or vandalism of the hatchery and take corrective action to protect and/or restore the functionality of necessary equipment. If housing is not provided, position will be required to adhere to a schedule to perform similar functioning.
